The Contractor also agrees to mediate all complaints registered to the Department of Consumer Affairs for resolution.

- If the contract supplies the Property Owner/ Agent with permits, signs and/or any other service product other than the impound services outlined in this contract and this contract is terminated before said expiration date, the Property Owner/Agent shall be held responsible to contact the Contractor to remove the materials at no charge to the Property Owner/ Agent provided such written notice is provided at least 10 days prior to the termination date.
